- 1. ELIGIBILITY: The Family Dollar KIT KAT® Education Scholarship Program Sweepstakes ("Sweepstakes") is open only to legal residents of the 48 contiguous United States and the District of Columbia, who are at least eighteen (18) years of age or older as of time/date of entry. Employees, officers and directors of The Hershey Company ("Sponsor"), Family Dollar Stores, LLC, Realtime Media LLC ("Administrator") and their respective parent companies, affiliates, subsidiaries, advertising, contest, fulfillment and marketing agencies (collectively, the "Sweepstakes Parties"), their immediate family members and those living in the same household as such individuals (whether legally related or not) are not eligible to participate in the Sweepstakes or win a prize. Non-winning entries <u>will</u> carry forward to subsequent Monthly Entry Periods. The designated computer clock of the Sponsor or Administrator is the official time-keeping device in the Sweepstakes.

## 3. HOW TO ENTER: There are multiple ways to enter this Sweepstakes:

- Registration Entry: During the Sweepstakes Period, visit <a href="https://www.familydollar.com/kitkateducation-scholarships-fd">https://www.familydollar.com/kitkateducation-scholarships-fd</a>. Then, complete and submit an official entry form, which may include, but is not limited to, your full name, email address, ZIP code, and date of birth. You will receive one (1) entry into the Sweepstakes for the applicable Monthly Entry Period upon registration for the first time only ("Registration Entry"). If you complete a Registration Entry and upload an eligible Receipt with one (1) Qualifying Product (as described below) on the same calendar day, you will receive two (2) entries for that applicable Monthly Entry Period. You can only complete a Registration Entry one (1) time during the Sweepstakes Period. Entry one (1) time during the Sweepstakes Period.
- Make a Purchase for Additional Entries: For this method only, you must first complete the steps for a Registration Entry. During the Sweepstakes Period, visit a participating Family Dollar store and make a qualifying purchase of at least one (1) eligible KIT KAT® bar (list of participating products can be found in Appendix A) ("Qualifying Purchase"). Then, scan the QR code on specially marked merchandising units and visit the Website, and if you already completed a Registration Entry as described above, you may simply follow the on-screen instructions to upload a clear and complete photo of your unique receipt that shows the store name, and product SKU ("Receipt") to receive one (1) entry into the Sweepstakes for the applicable Monthly Entry Period. You may also visit the Website directly without scanning the QR code. On subsequent days, you may simply return to the Website and submit your email address and log in to upload another unique Receipt. You will receive one (1) entry for each unique Receipt you upload per day for the applicable Monthly Entry Period subject to the limit below. You cannot enter by solely scanning the QR code.

If you do so, you will receive five (5) Bonus entries into the Sweepstakes drawing for the applicable Monthly Entry Period, subject to the Bonus Entry limit below. Each entry must be mailed separately in a hand-addressed, stamped envelope. No photocopied or mechanically reproduced entries will be accepted. Sponsor is not responsible for postage-due entries or for any incorrect or illegible data contained in any Sweepstakes entry. The Sweepstakes Parties are not responsible for technical malfunctions or difficulties of any kind, or for false, incorrect, changed, incomplete or illegible contact information.

Receipts are subject to verification. A unique Receipt may only be used once to submit an entry into the Sweepstakes. A Receipt may not be used by more than one (1) entrant. Receipts must be readable. Mechanical reproductions, altered receipts, digital receipts, or unreadable receipts will not be accepted.

SWEEPSTAKES DRAWINGS: There will be eight (8) potential winners selected in this Sweepstakes, two (2) per Monthly Entry Period, via a random drawing on or about the dates set forth in chart above from among all eligible entries received for the applicable Monthly Entry Period (and any carryover entries from prior Monthly Entry Periods) in accordance with these Official Rules.

WINNER NOTIFICATION/PRIZE CLAIMING: The potential winners will be notified via email using the information provided on the entry form in a commercially reasonable time after the applicable drawing. The Sweepstakes Parties are not responsible for and shall not be liable for false, incorrect, changed, incomplete or illegible contact information or for electronic communications that are undeliverable as a result of any form of active or passive filtering of any kind, or insufficient space in entrant's email or other account to receive messages or late, lost, damaged, intercepted, misdirected, or unsuccessful efforts to notify a potential winner. Notification is deemed to have occurred immediately upon sending of an email. If a potential winner cannot be contacted within a reasonable time period, if potential winner is ineligible, if any notification is returned undeliverable, or if a potential winner otherwise fails to fully comply with these Official Rules, that potential winner will forfeit that prize and an alternate winner may be selected from among all

remaining eligible entries for the applicable drawing. Winners will be solely responsible for all federal, state and/or local taxes, and for any other fees or costs associated with the prizes received, regardless of whether they, in whole or in part, are used. The ARV of the prizes is based on available information provided to Sponsor as of the time these Official Rules are printed and may fluctuate. The value of a prize awarded to a winner will be reported for tax purposes as required by law. The winners of such prize will be required to provide Sponsor with a valid social security number before each prize will be awarded for tax reporting purposes. An IRS Form 1099 will be issued in the name of winners for the actual value of a prize received. Any unclaimed prize will be forfeited. Prizes, if legitimately claimed, will be awarded. The Sweepstakes Parties are not responsible for and will not replace any lost, mutilated or stolen prizes or any prize that is undeliverable or does not reach a winner because of an incorrect or changed address. If a winner does not accept or use the entire prize, the unaccepted or unused part of the prize will be forfeited and the Sweepstakes Parties will have no further obligation with respect to that prize or portion of that prize. The Sweepstakes Parties do not assume any responsibility for any disruption in the Sweepstakes, including, but not limited to, the failure or interruption of any social media platform or any internet service provider. Sponsor additionally reserves the right, in its sole and absolute discretion: (a) to modify, suspend or terminate the Sweepstakes should causes beyond Sponsor's control corrupt or interfere with the administration, integrity, operation, security or proper play of the Sweepstakes; or (b) to disqualify any entrant found to be, or suspected of: (i) tampering with the entry process or the operation of the Sweepstakes; (ii) acting in violation of these Official Rules; or (iii) acting in an un-sportsmanlike manner.
- 9. CONDUCT: The Sweepstakes Parties are not responsible for the actions of entrants in connection with the Sweepstakes, including entrants' attempts to circumvent the Official Rules or otherwise interfere with the administration, security, fairness, integrity or proper conduct of the Sweepstakes. SOME

JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY, SO THE ABOVE MAY NOT APPLY TO YOU.

- 13. DISPUTE RESOLUTION: The parties each agree to finally settle all disputes only through arbitration; provided, however, the Sponsor shall be entitled to seek injunctive or equitable relief in the state and federal courts in the Commonwealth of Pennsylvania, and any other court with jurisdiction over the parties. In arbitration, there is no judge or jury and review is limited. The arbitrator's decision and award is final and binding, with limited exceptions, and judgment on the award may be entered in any court with jurisdiction. The parties agree that, except as set forth above, any claim, suit, action or proceeding arising out of or relating to this Sweepstakes shall be resolved solely by binding arbitration before a sole arbitrator under the streamlined Arbitration Rules Procedures of JAMS Inc. ("JAMS") or any successor to JAMS. In the event JAMS is unwilling or unable to set a hearing date within fourteen (14) days of the filing of a "Demand for Arbitration", then either party can elect to have the arbitration administered by the American Arbitration Association ("AAA") or any other mutually agreeable arbitration administration service. If an in-person hearing is required, then it will take place in the Commonwealth of Pennsylvania. The federal or state law that applies to these Official Rules will also apply during the arbitration.
